Instruction for conducting security clearance

Security clearance shall be based on an overall security assessment and a security approval interview which verifies that the individual is reliable and loyal and that nothing has emerged that constitutes an obstacle from a security and safety point of view.

Security clearance shall be carried out by the company's CEO, HR manager, Security protection officer or equivalent responsible person at the company.

Security assessment

Security assessments shall verify that the assessed person is reliable and loyal by:

- Knowledge of the person and experience within the company's organization
- Confirmed information provided by grades, certificates and references

Security approval interview

Security approval interview shall be conducted by obtaining information to establish that an assessed person is reliable from a safety and security perspective.

The interview should at least cover the following topics:

1. Family relationships
2. Hobbies
3. Involvement in leisure associations
4. Private involvement in other business activities
5. Residential and living environment
6. Trips abroad, to where and how often
7. Foreign contacts
8. Criminal record - Convicted for a criminal offense
9. Contacts with criminally convicted individuals
10. Use of alcohol or drugs
11. Information on social media (about oneself at eg facebook or twitter)
12. Private financial situation
13. Safety awareness (at work and private)
14. Any other information that may affect the overall security clearance
15. Own thinking about safety and security issues
