STORAGE CONTRACT

(hereinafter referred to as "Uniper Energy Storage")

Article 1

General Terms and Conditions

The "General Terms and Conditions for Storage Services" (hereinafter referred to as "GTCS") of Uniper Energy Storage are an integral part of this contract. The GTCS ruling at the time the contract is concluded can be consulted on the website of Uniper Energy Storage (<https://www.uniper.energy/energy-storage-uniper/infocenter/publications>) and a copy can be posted to the Storage Customer on request. Deviating General Terms and Conditions of the Storage Customer shall not apply even if Uniper Energy Storage does not expressly contradict those conditions.

Article 2

Object of the Contract

1. Uniper Energy Storage undertakes to make available to the Storage Customer the storage capacities listed in Annex I of this contract in the storage facility and for the storage period therein named and to provide the associated storage services and system services. The scope and content of these obligations are set forth in this contract and in the related GTCS including the various respective annexes.
2. The Storage Customer undertakes to use the storage capacities within the scope of the conditions set forth in this contract and in the GTCS including the conditions set forth in the various respective Annexes, in particular the Technical Framework Conditions (Annex III of the GTCS), and to pay the storage fee indicated in Annex I for the storage capacities booked by him. The Storage Customer undertakes in particular to use the injection and withdrawal rate booked by him only according to the individual injection and withdrawal curves shown in Annex I of this contract and explained, where appropriate, more fully in Annex III of the GTCS.

Article 3

Fees, Price Revision

1. The total storage fee consists of:
 - a) the annual storage fee or, when storage capacities are booked over a period measured in months, the monthly storage fee; this is dependent upon which firm and/or interruptible, bundled and/or unbundled storage capacities the Storage Customer has booked;

- b) the fee for variable costs according to Article 4 GTCS that is tied to the actual gas turnover;
- c) the system service fee, consisting of an annual flat-rate amount according to Article 3 GTCS.

The total fee that is specifically payable by the Storage Customer is shown in Annex I of this contract. All fees are net prices.

2. If storage capacities are booked for a period of at least one year, the annual storage fee, the annual system service flat fee and the fee for variable costs will be revised according to the price revision formulas given in Annex IV of the GTCS, the revision taking effect at the beginning of each storage year (06.00 hours on 1 April) that follows the date when the contract was concluded. The first price revision will be **on 1 April 2026**.

The base year for the index values given in the price revision formulas is the calendar year 2007. The basic fees for the price revision are

- for the annual storage fee for firm bundled storage capacities:
VALUE DEPENDING ON THE STORAGE FACILITY
- for the annual storage fee for firm unbundled withdrawal rate:
VALUE DEPENDING ON THE STORAGE FACILITY
- for the annual storage fee for firm unbundled working gas capacity:
VALUE DEPENDING ON THE STORAGE FACILITY
- for the annual storage fee for firm unbundled injection rate:
VALUE DEPENDING ON THE STORAGE FACILITY
- for the annual system service flat fee: € 10,000
- for the fee for variable costs: 42 €-cents per MWh of injected working gas

The revised annual storage fees and annual system service fees shall be rounded up or down to amounts of whole Euros.

If the index values given in the price revision formulas are no longer published, they shall be replaced by the published index values which closest approximate to these index values. The same applies if the publications are no longer made by the Statistisches Bundesamt (German Federal Statistical Office).

Article 4

Exchange of Information

1. The Storage Customer and Uniper Energy Storage nominate contact addresses to each other for the purpose of exchanging information. The Storage Customer guarantees the constant availability of a contact partner for issues of contract implementation such as nomination, matching and allocation. In addition, the Storage Customer provides Uniper Energy Storage with all information necessary for the execution of this contract.
2. Nominated contact persons on the part of Uniper Energy Storage are the persons listed on Uniper Energy Storage's website <https://storage-portal.uniper.energy/#/contacts>.
3. Immediately after the conclusion of this contract, the Storage Customer shall name its contact persons and provide the necessary data. For this purpose, the storage customer shall fill in all mandatory fields specified there in the storage portal under "My account" in the tab "My data → Contact sheet of your company". The storage customer is also obligated to update this information immediately via the storage portal in the case of changes regarding these contact persons and data. The update shall take effect seven working days after the storage customer has made the update.
