## **About Uniper**

## **Consultation Questions**

1. Do you have any views on the proposed new security and resilience roles?

The proposed new security and resilience roles are appropriate for the FSO. Recent work by industry and government has considered the interaction between the electricity and gas systems and this proposal will address identified issues.

2. Do you have any views on the proposed new National Security power, and duty on the FSO?

There is no doubting the levity of national security and the importance of the energy system and continuity of essential services to national wellbeing. Whilst we can understand the case for the Secretary of State to be given a national security power, we would normally expect the enactment of something so important to be through primary or secondary legislation. The licence of the FSO appears to be too far down the legislative order to be addressing such serious concerns. This gives rise to other questions which require further thought. What happens if complying with this licence condition clashes with other legal requirements of the FSO contained in primary or secondary legislation? If the FSO complies with a direction from the Secretary of State and this has consequential effects on other parties, will the FSO enact code changes to direct other parties? Will there be a process to compensate affected parties if this power is used?
